- 551.082 Considering discipline of a public-school child, or complaint or charge against an employee by another employee.
- 551.0821 Considering a matter that will necessarily reveal personally identifiable information about a public-school student.
- 551.087 Discussing or deliberating on economic development negotiations.


Education Code

- (a) in the open meeting covered by the Notice upon the reconvening of the public meeting; or
